Description:

Kills Common Household pest : House Flies , Mosquitoes , Cockroaches , Fire Brats, Small Flying Moths , Gnats , Ants , Crickets , Crickets , Carpet Beetles , confused Flour Beetles ,Saw - Toothed Grain Beetles , Rice Weevils , Sowbugs , Centipedes , Spiders , Fleas and Brown Dog Ticks .

1) For household use and nonfood areas of industrial and institutional buildings including:

interior and exterior of upholstered furniture , both top and bottom of rugs and carpets , shelves , closets , areas under furniture and wherever these insects are seen or suspected . Also cracks , crevices , hidden surfaces under sinks , behind stoves and refrigerators ; sleeping quarters of pets , around baseboards , window and door frames , wall cracks , and local areas of floors . Do not spray animals . (Note : It is a violation of federal law to use this product in a manner inconsistent with its labeling . See product label copy for specific information).

2) For use as a space spray (indoor and outdoor) treatment against flying insects;

Flies, mosquitoes and gnats on screens, light fixtures and other surfaces where insects congregate: Move people, birds, and animals out of rooms. Close doors and windows. Spray short bursts towards ceilings. After 10-15 minutes, ventilate all rooms properly before staying inside.

Health hazard data: Caution: harmful if swallowed. Avoid prolong breathing of spray mist or repeated contact with skin. Do not contaminate food, foodstuffs, utensils, dishes or drinking water. Do not apply to areas that will be contacted frequently by children and do not allow them in treated areas until surfaces are dry. Do not apply to humans, pets, and birds or near fish bowls. Avoid excessive wetting of plastics, vinyl or asphalt tile. Ventilate all rooms properly before staying inside.

Statement of practical treatment: if *swallowed*: call a doctor or get medical attention. Do not induce vomiting. Do not give any thing by mouth to an unconscious person. Avoid alcohol. If in *eyes*: flush eyes with plenty of water. Call a physician if irritation persists. If *inhaled*: remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth to mouth. Get medical attention.

Note to physician: *Atropine Sulfate is antidotal.*

Physical or chemical hazards: Extremely flammable. Contents under pressure. Keep away from fire, sparks, and heated surfaces. Do not puncture or incinerate container. **Keep out of reach of children.** Exposure to temperatures above 50 degrees centigrade may cause bursting.

Spill or leakage procedures: Do not flush to sewer. Absorb with suitable material and dispose off according to local regulations. Aerosol cans when vented to atmospheric pressure through normal use, pose no disposal hazard.
